# DEMENTIA FRIENDLY COMMUNITIES IN ENGLAND



#### **DEMCOM**

The DEMCOM study is a national evaluation of dementia friendly communities (DFCs) in England. Using different research methods it aimed to understand how different types of DFCs work, what is needed to sustain them and how they help different groups of people affected by dementia to live well.

We used the following definition of DFCs:

"A Dementia Friendly
Community can involve a wide
range of people, oganisations
and geographical areas. A DFC
recognises that a person with
dementia is more than their
diagnosis and that everyone
has a role in supporting their
independence and inclusion"

#### AT A GLANCE

We looked at the **online information** of 100

DFCs and evaluated 6 in more detail

We reviewed 300 **documents** 

We involved 385 **participants**, 63% of these were people affected by dementia\*

\*people living with dementia and their carers

- DFC provision matches the numbers of people living with dementia
- 95% of DFCs were set up as a result of government policy
- DFCs emphasised awareness raising but impact was unclear
- DFCs offered both services for people with dementia and services to help people stay in their community
- People with dementia were involved but not always in decision making

### Our guidance for DFCs in England

#### Strong leadership

and a history of working together creates a secure basis for planning, discussion and wider community work

#### Allocated resources

are important to target awareness raising activities with key services (e.g. transport), key populations and groups. Ideally, DFCs will have paid staff members or receive funding from the local authority.

#### **Activities**

and the work of the DFC should challenge existing services that exclude people with dementia and link formally with statutory services to encourage monitoring & evaluation of progress.

#### **Basis of DFC**

enables DFCs to understand the needs and wishes of the local community and leads to...
